# Synopsis of the meeting held in Paris on 19 March 2019

The Committee on Social Affairs, Health and Sustainable Development, meeting in Paris on 19 March 2019, with Mr Stefan Schennach (Austria, SOC), Chairperson, in the Chair, as regards:

- Sustainable urban development fostering social inclusion (Rapporteur: Ms Sybille Benning, Germany, EPP/CD): considered a draft report and unanimously adopted a draft resolution, with a view to presenting the report for debate at the Standing Committee in Paris, on 24 May 2019;
- Air quality and diesel emissions in urban centres (Rapporteur: Mr Serhii Kiral, Ukraine, EC):
   considered a preliminary draft report and decided to change the title to "Air pollution: a challenge for public
   health in Europe";
- The societal impact of the "platform economy" (Rapporteur: Mr Luís Leite Ramos, Portugal, EPP/CD): considered a preliminary draft report;
- Protecting the rights of people with psychosocial disabilities with regard to involuntary measures in psychiatry (Rapporteur: Ms Reina de Bruijn-Wezeman, Netherlands, ALDE): considered a preliminary draft report and agreed to make it available to the Council of Europe Committee on Bioethics (DH-BIO), the Council of Europe Commissioner for Human Rights, and the PACE Committee on Equality and Non-Discrimination; decided to change the title to "Ending coercion in mental health: the need for a human-rights based approach";

and heard from them a declaration of absence of conflict of interests:

- took note that Baroness Doreen Massey resigned from her rapporteurship (for opinion) on "Missing refugee and migrant children in Europe";

- Ending violence against children: a Council of Europe contribution to the Sustainable Development Goals (Rapporteur: Baroness Doreen Massey, United Kingdom, SOC): considered a preliminary draft report and, (subject to the availability of funds) authorised the rapporteur to undertake a fact-finding visit to Berlin (Germany), to be combined with that to be carried out in the framework of her report on "Stepping up co-operation between European initiatives for better child protection against sexual violence";

- Stepping up co-operation between European initiatives for better child protection against sexual violence (Rapporteur: Baroness Doreen Massey, United Kingdom, SOC): considered an introductory memorandum and decided to change the title to "Addressing sexual violence against children: stepping up action and co-operation in Europe";
- Combating trafficking in human tissues and cells (Rapporteur: Mr Serhii Kiral, Ukraine, EC): considered an introductory memorandum and agreed to submit to the Bureau a request for an extension of the reference until 31 December 2019 for this report, as well as for the report on "Organ transplant tourism" (Rapporteur: Ms Stella Kyriakides, Cyprus, EPP/CD), with a view to presenting the two reports for a joint debate in the Assembly during the first part-session 2020;

 Václav Havel Human Rights Prize: took note of the call for nominations for the 2019 Václav Havel Prize, and of the fact that the deadline for applications was 30 April 2019;
