# Synopsis of the meeting held in a hybrid manner on 1 December 2021

The Committee on Social Affairs, Health and Sustainable Development, meeting on Wednesday, 1 December 2021, with first Ms Edite Estrela (Portugal, SOC) Second Vice-Chairperson, and Mr Andrej Hunko (Germany, UEL), Third Vice-Chairperson, in the Chair, then Mr Luís Leite Ramos (Portugal, EPP/CD), Chairperson, in the Chair, as regards:

- **The Covid-19 situation:** unanimously adopted a Committee declaration;
- Addiction to prescribed medicines (Rapporteur: Mr Joseph O'Reilly, Ireland, EPP/CD): heard a report back from the rapporteur on his fact-finding visit to Denmark, approved the proposed change in the title of the report, considered a draft report and unanimously adopted a draft resolution and a draft recommendation with a view to presenting the report for debate during the meeting of the Assembly's Standing Committee on 11 March 2022;
- Inaction on climate change a violation of children's rights (Rapporteur: Ms Jennifer De Temmerman, France, ALDE): in the absence of the Rapporteur, heard a video message from the Rapporteur presenting the draft report, considered the draft report and unanimously adopted a draft resolution as amended and a draft recommendation, with a view to presenting the report for a joint debate with the report "The right to be heard: child participation, a foundation for democratic societies" during the January 2022 part-session of the Assembly;
- The right to be heard: child participation, a foundation for democratic societies (Rapporteur: Baroness Doreen E. Massey, United Kingdom, SOC): in the absence of the Rapporteur, heard a message from the Rapporteur presenting the draft report, authorised the Rapporteur to add additional information to the explanatory memorandum after the meeting, in order to reflect the outcomes of the meeting of the Sub-Committee on Children on 22 November 2021, approved the proposed change in the title of the report, considered the draft report and unanimously adopted a draft resolution and a draft recommendation with a view to presenting the report for a joint debate with the report "Inaction on climate change a violation of children's rights" during the January 2022 part session of the Assembly;
- The climate crisis and the rule of law (former Rapporteur: Ms Edite Estrela, Portugal, SOC): as a follow-up to Resolution 2399 (2021), unanimously adopted the terms of reference of the Network of Contact Parliamentarians for a healthy environment, for submission to the Bureau of the Assembly;
