Dear Secretary General,

I ain writing you with reference to your letter dated 29 January 2008, in which you had informed about the Parliamentary Assembly's decision to invite the Government of Azerbaijan to submit a new fist of candidates for the post of judge at the European Court of Human Rights.

I should like to note, at the outset, that following this decision the Government of Azerbaijan has repeated the whole procedure for selection of candidates, which had been commended by the Committee of Ministers. The request for nomination of candidates was submitted to the Judicial-Legal Council of the Republic of Azerbaijan, an independent body, which among its other functions conducts procedure of selection of candidates for the post of judge at the domestic level, and promotion of judges.

Despite the low level of knowledge of official languages of the Council of Europe among the legal professionals in Azerbaijan, which is undoubtedly affecting the availability of competent candidates, the procedure followed fully satisfied the criteria of transparency, fairness and openness. Moreover, in drawing up the list of candidates all efforts were applied to satisfy the criterion for a balanced representation of women and men, and to provide the Parliamentary Assembly with a real choice among the well-qualified candidates.

The Judicial-Legal Council, having regard to the Parliamentary Assembly Resolution 1200 (1999) and Recommendations 1420 (1999) and 1649 (2004) followed the procedure for the selection of the candidates as follows:

- the call for candidates was published anew in the specialised "Adalet" newspaper as well as "Iki sahil", "Olayiar" and other newspapers; on the web-sites of information agencies and of the Judicial-Legal Council, the Supreme Court and the Ministry of Justice of the Republic of Azerbaijan;
- 14 candidates have been nominated by the judge's associations, non-governmental organisations, and individually;

- upon expiration of the set deadline, candidates, who met the requirements of the high post of judge of the European Court of Human Rights, were interviewed by the Subcommittee for selection of candidates of the Judicial-Legal Council;
- the list of candidates was submitted to the plenary of the Judicial-Legal Council.

Judicial-Legal Council, chaired by the President of the Supreme Court of the Republic of Azerbaijan, at its plenary meeting examined the applications received and the recommendations of the Sub-committee for selection of candidates, and decided to propose the Government to submit the following candidates:

- 1. Mr Khanlar Hajiyev Judge at the European Court of Human Rights;
- Ms Saadat Yusivofa Consultant to the Department for Coordination of Law Enforcement Bodies, Administration of the President of the Republic of Azerbaijan;
- 3. Mr Rovshan Ismayilov Associate Professor, Department of Constitutional Law, Baku State University.

I enclose to this letter the curricula vitae of the above candidates, and should like to express our firm belief that the three candidates submitted are satisfying the criteria laid down in Article 21 § 1 of the European Convention on Human Rights.

Information on establishing the candidates' list for the election of the judge for the European Court of Human Rights

Government of Montenegro, at its session held on July 19th, 2007 made a decision to set up the Commission for establishing a candidates' list (assuming three candidates) for the election of the judge for the European Court of Human Rights.

According to the conclusions from the above mentioned session, Ministry of Justice was urged to proclaim the Announcement for establishing the candidates' list for the election of the judge for the European Court of Human Rights. Announcement was in line with the policy of the European Convention for Protection of Human Rights and Fundamental Freedoms and other Council of Europe documents referring to the election of the judge for the European Court of Human Rights. The main requirements from this Announcement were that candidates spoke fluently one of the CoE official languages and had 15 years of working experience in legal affairs.

Due to lack of candidates who met the criteria stated in the Announcement, the Announcement was republished.

On its meeting held on December 26th, 2007, the Commission thoroughly examined the Report on conducted interviews and reviewed received applications. Accordingly, the Commission concluded that the following three candidates fulfilled the criteria (in alphabetical order): MA Vesna Čejović, Mr. Darko Ćurić and PhD Nebojša Vučinić. In that regard, the Commission unonimously adopted the list of the three above mentioned candidates (CVs are enclosed), which the Government approved at its session held on December 27th, 2007.

Throughout my entire professional career, human rights have been one of the central issues. Acting as a criminal judge in the early stages of a newly established democracy I had to pay major attention to internationally recognized human rights standards in the criminal proceedings which at that time were not yet embedded in our legal tradition – the ECHR, the decisions of the former Commission and judgements of the Court were often the main sources of my reasoning.

One of the main tasks of my work at the Ministry of Justice was the implementation of human rights standards as stipulated in the Convention in Slovenian penal legislation.

As a Council of Europe expert I have usually been engaged in environments where human rights needed to be strongly and consistently (not politically but on an expert level, e.g. by quoting judgements of the ECHR) promoted.

As a director of the preventive anticorruption body I had the opportunity (through monitoring of the functioning of state bodies as well as through hundreds of complaints of citizens) to deal with a wide range of alleged violations of human rights, apart from those exclusively linked to criminal law.

Currently I am directing and supervising investigations of organized crime where as a rule suspects are detained, property is being seized, special investigative means are being used and undercover police activities are being conducted. Jurisprudence of the ECHR is always a firm and reliable orientation in establishing the proper, very subtle balance between the efficiency of the proceedings and respect for human rights of individuals.
